ELIGIBILITY CRITERIA FOR MEMBERSHIP:

- 1. Membership is open to Professional Agrawals who are working / living in and around Ahmedabad.
- 2. All applications for admission shall be considered by the Executive Committee of the Association. No person can claim membership as a matter of right. The Executive Committee shall be competent to refuse admission to any person without assigning any reason.
- 3. The following persons shall be deemed to be professionals for the purpose of admission to APCA:
- (I). Any person serving in / retired from Government, Semi-Government, Public Sector Undertaking or any Institution established under an Act of Parliament or any State Legislature, provided
 - i. Such person is a Graduate from any a recognized University and Minimum Class II Officer or equivalent level at the time of taking up the employment. And
 - ii. Such person should be in / retired in Class I category at the time of application for membership of APCA:
- (II). Any person serving in / retired from Armed Forces, who had joined the Armed Forces at a position not lower than Commissioned Officer;
- (III). Any Person who is a Graduate and / or Post Graduate in Engineering, Medicine or Law from a recognized University or Deemed University and who is engaged in the same profession either in employment or in practice;
- (IV). Any person who is a member of The Institute of Chartered Accountants of India (ICAI), The Institute of Cost and Works Accountants of India (ICWAI) or The Institute of Company Secretaries of India (ICSI) and who is engaged in the same profession either in employment or in practice;
- (V). Any person who is a Post Graduate in Management from a recognized University or Deemed University;
- (VI). Any person who has done Post Graduate Diploma in Business Management or Fellow Programme in Management (FPM) from any of the Indian Institutes of Management (IIMs) or any other Institution, where entry to the course is through the Common Admission Test (CAT);
- (VII). Any person who has been awarded a Ph.D. by a recognized University or Deemed University and who is in the profession;
- (VIII). Any person who is working or retired as a 'Professor' / 'Reader' or is working in / retired from any higher position in a recognized College / University;
- (IX). In case of any person who is renowned or having any other specialty not covered above, the Executive Committee may consider his admission as a member of APCA, with the consent of at least 3/4th of the total strength of the Executive Committee.
